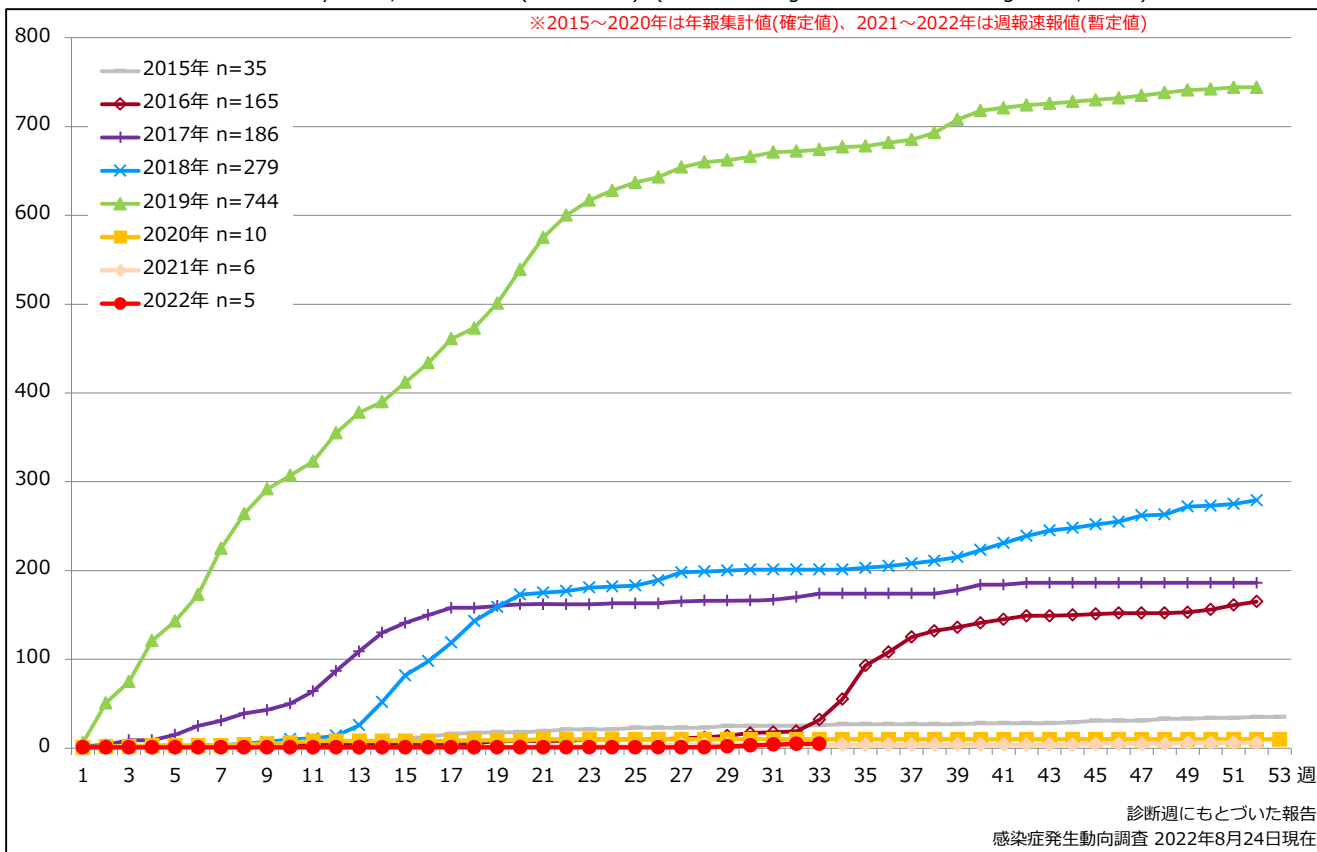


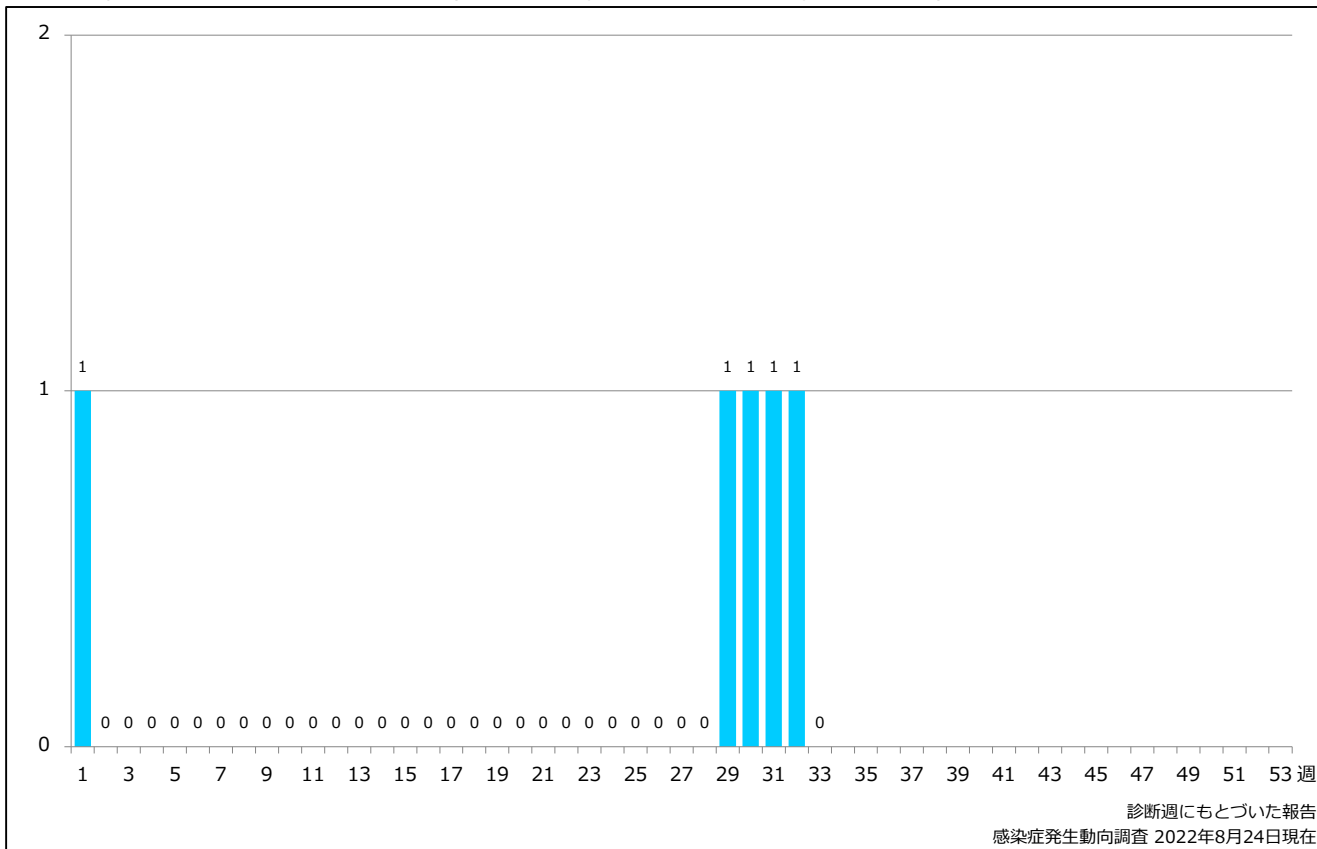
1. 麻疹累積報告数の推移 2015~2022年 (第1~33週)

2. 週別麻疹報告数 2022年 第1~33週 (n=5)

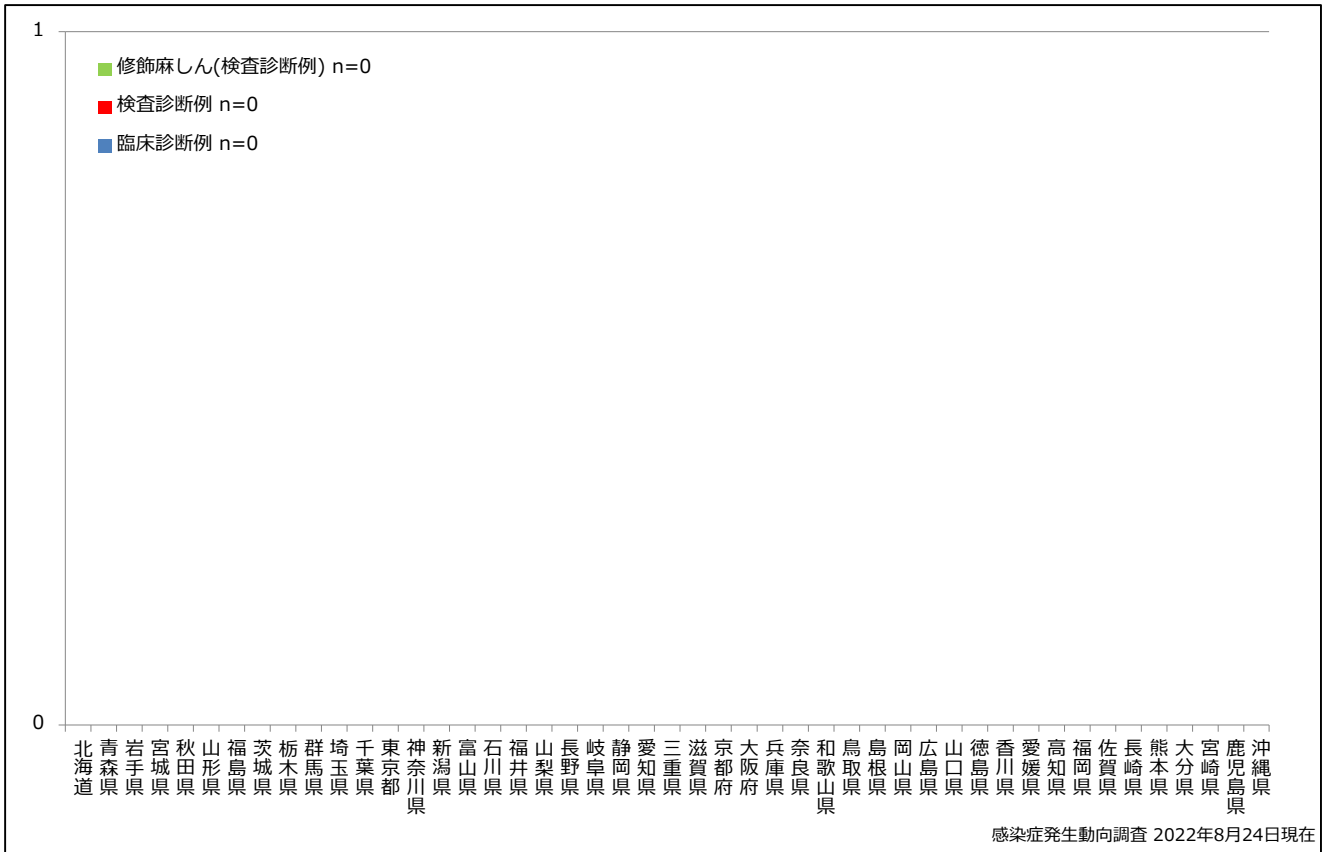
Weekly measles cases, week 1-33, 2022 (based on diagnosed week as of August 24, 2022)

Reported measles cases by prefecture and methods of diagnosis in week 33, 2022 (as of August 24, 2022)

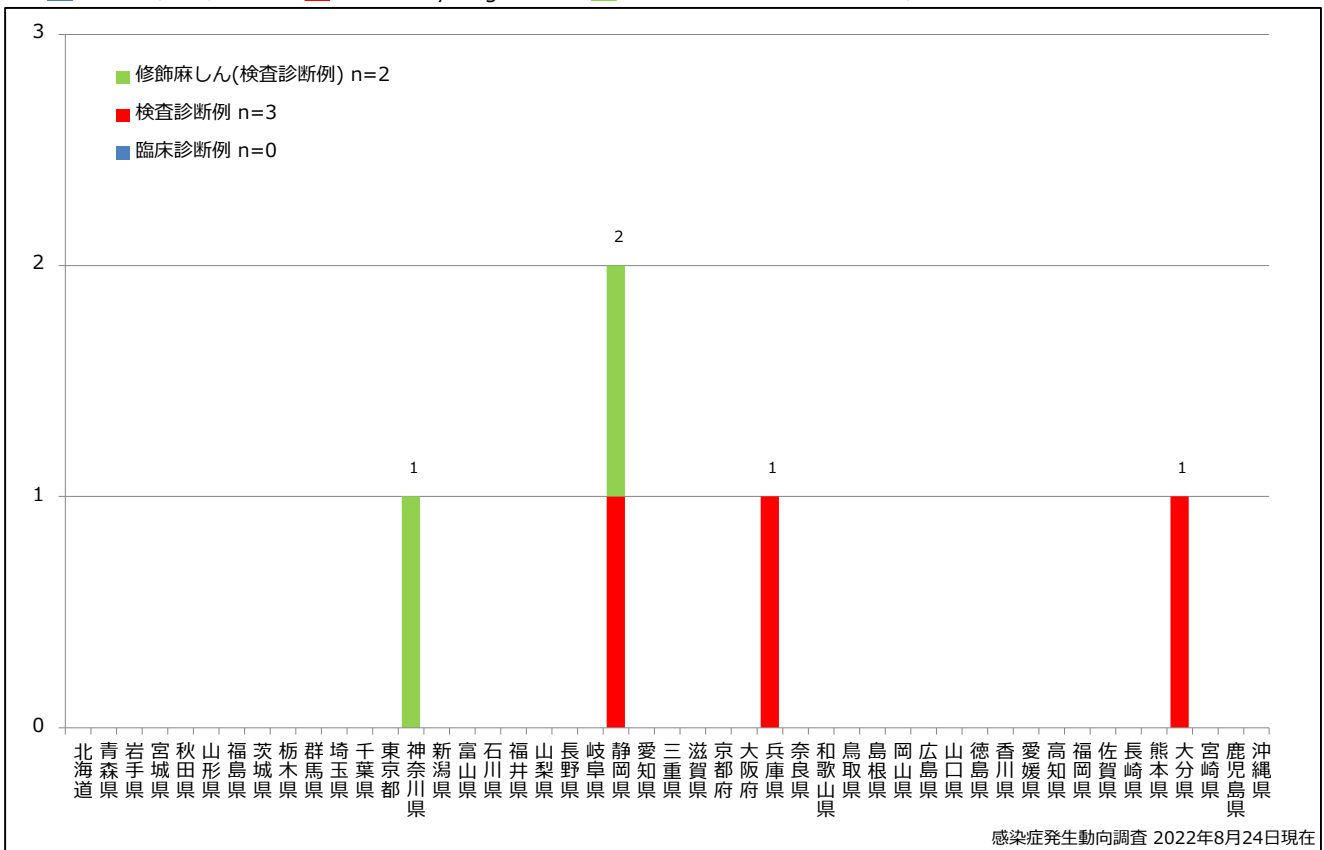

Cumulative measles cases by prefecture and methods of diagnosis, week 1-33, 2022 (as of August 24, 2022)

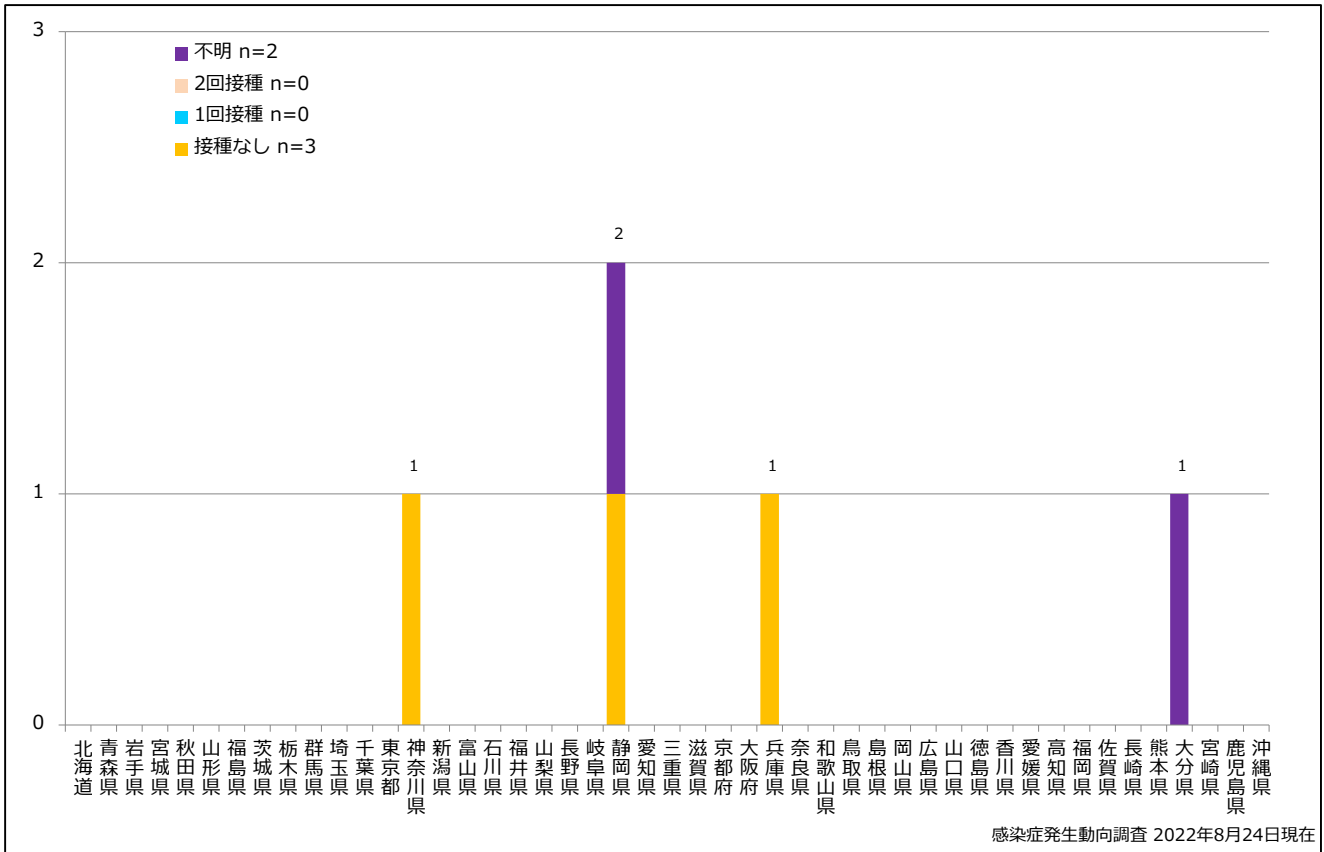

Cumulative measles cases by prefecture and vaccinated status, week 1-33, 2022 (as of August 24, 2022)

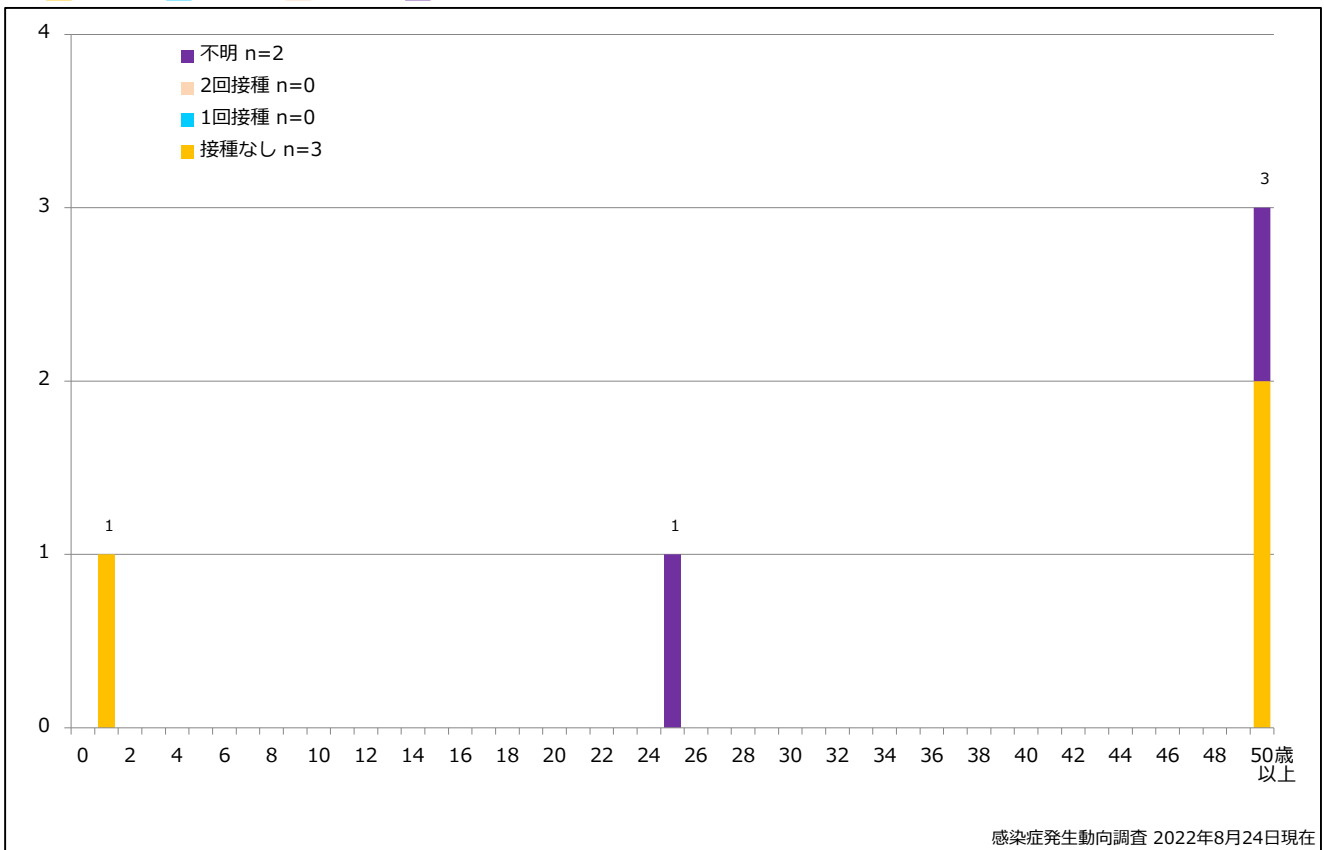

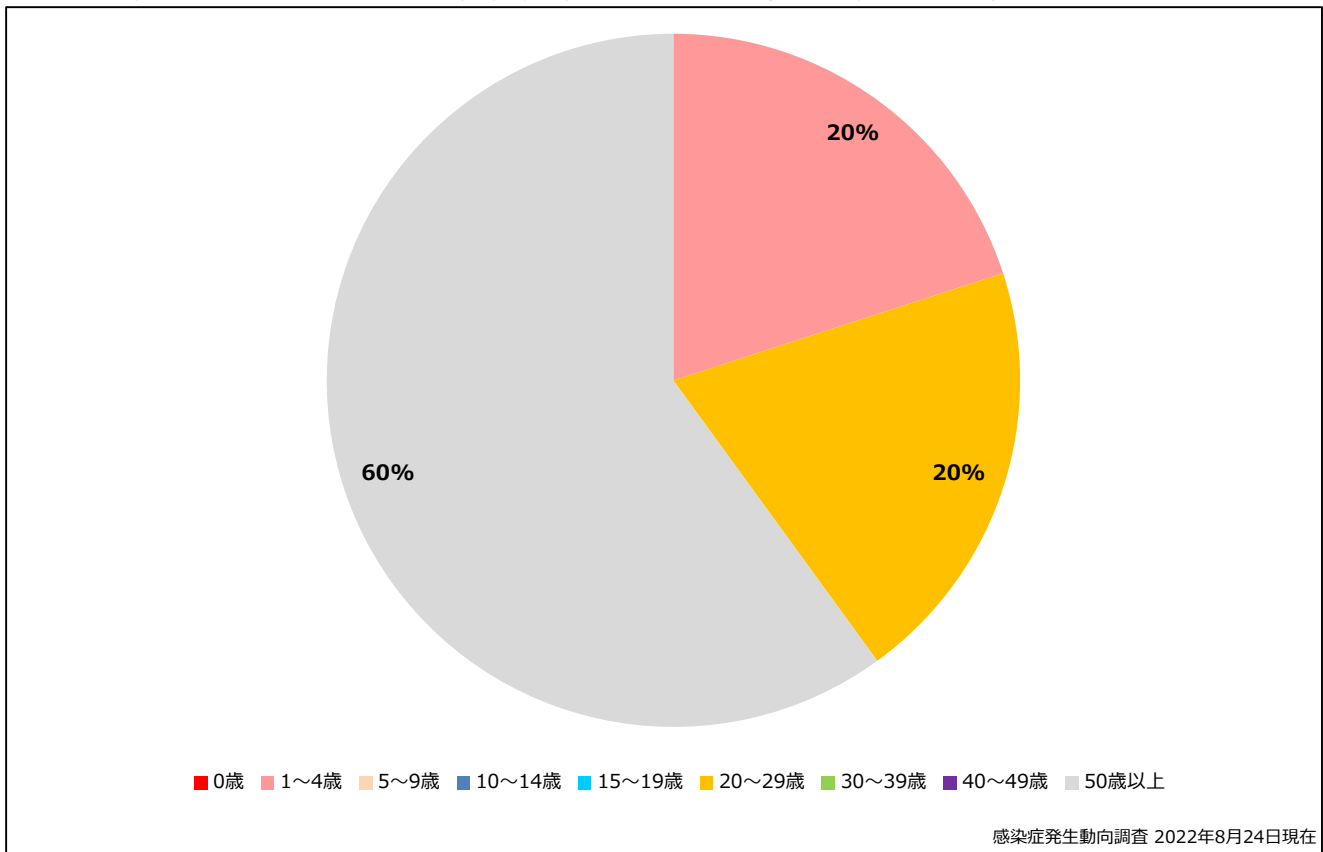
Cumulative measles cases by age and vaccinated status, week 1-33, 2022 (as of August 24, 2022)

7. 年齢群別麻疹累積報告数割合 2022年 第1~33週 (n=5)

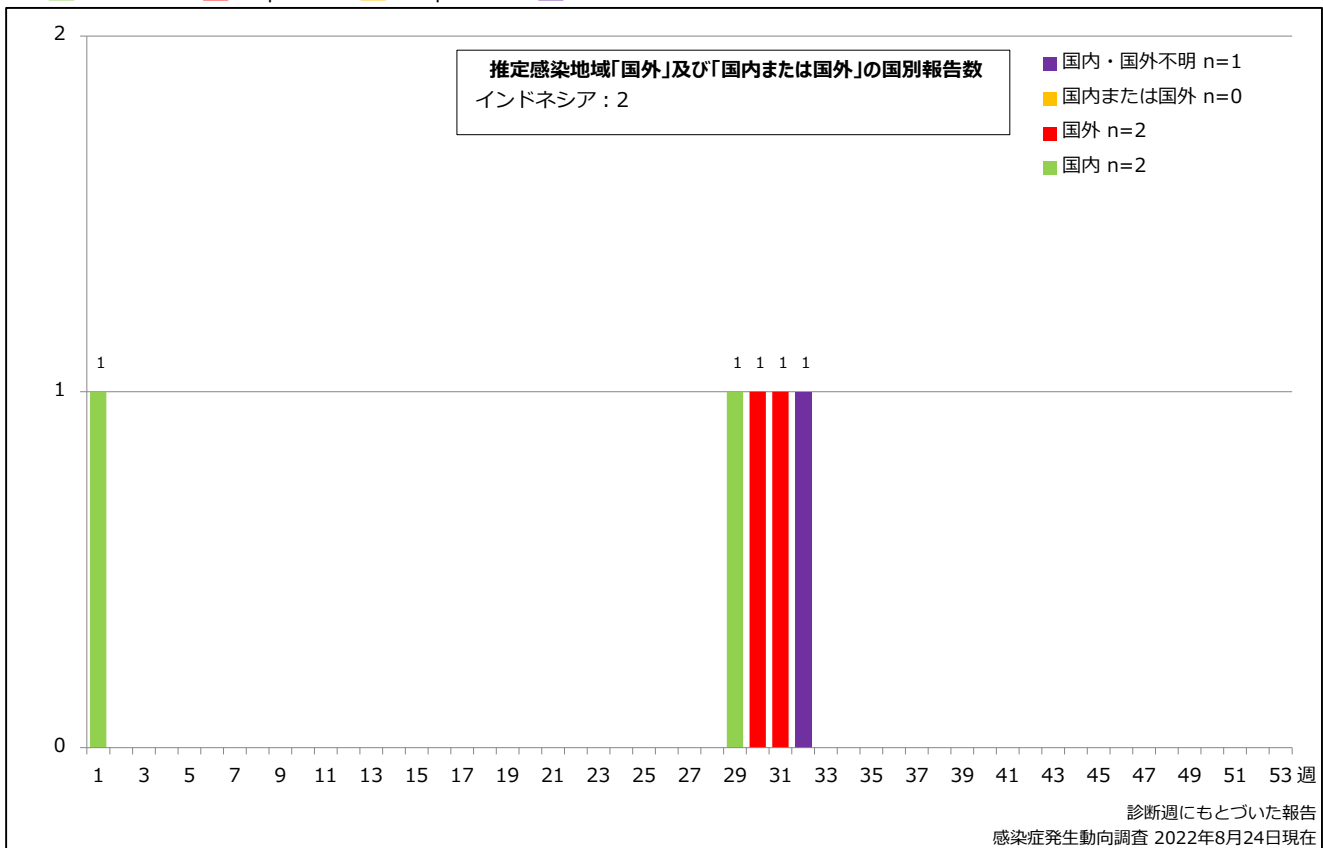
Percentage of cumulative measles cases by age group, week 1-33, 2022 (as of August 24, 2022)

Weekly measles cases by acquired region, week 1-33, 2022 (based on diagnosed week as of August 24, 2022)

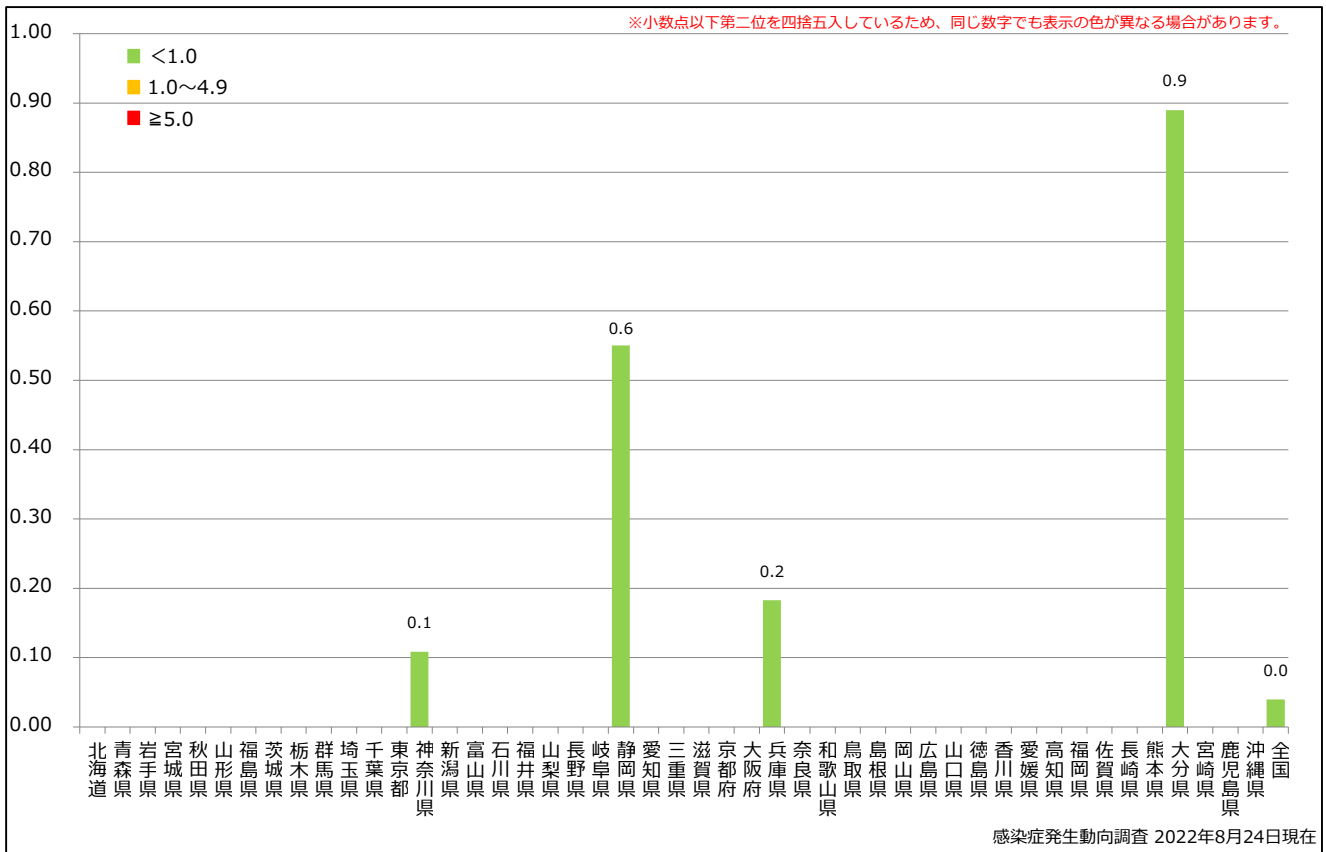

Reported measles cases per 1 million population by prefecture, week 1-33, 2022 (as of August 24, 2022)

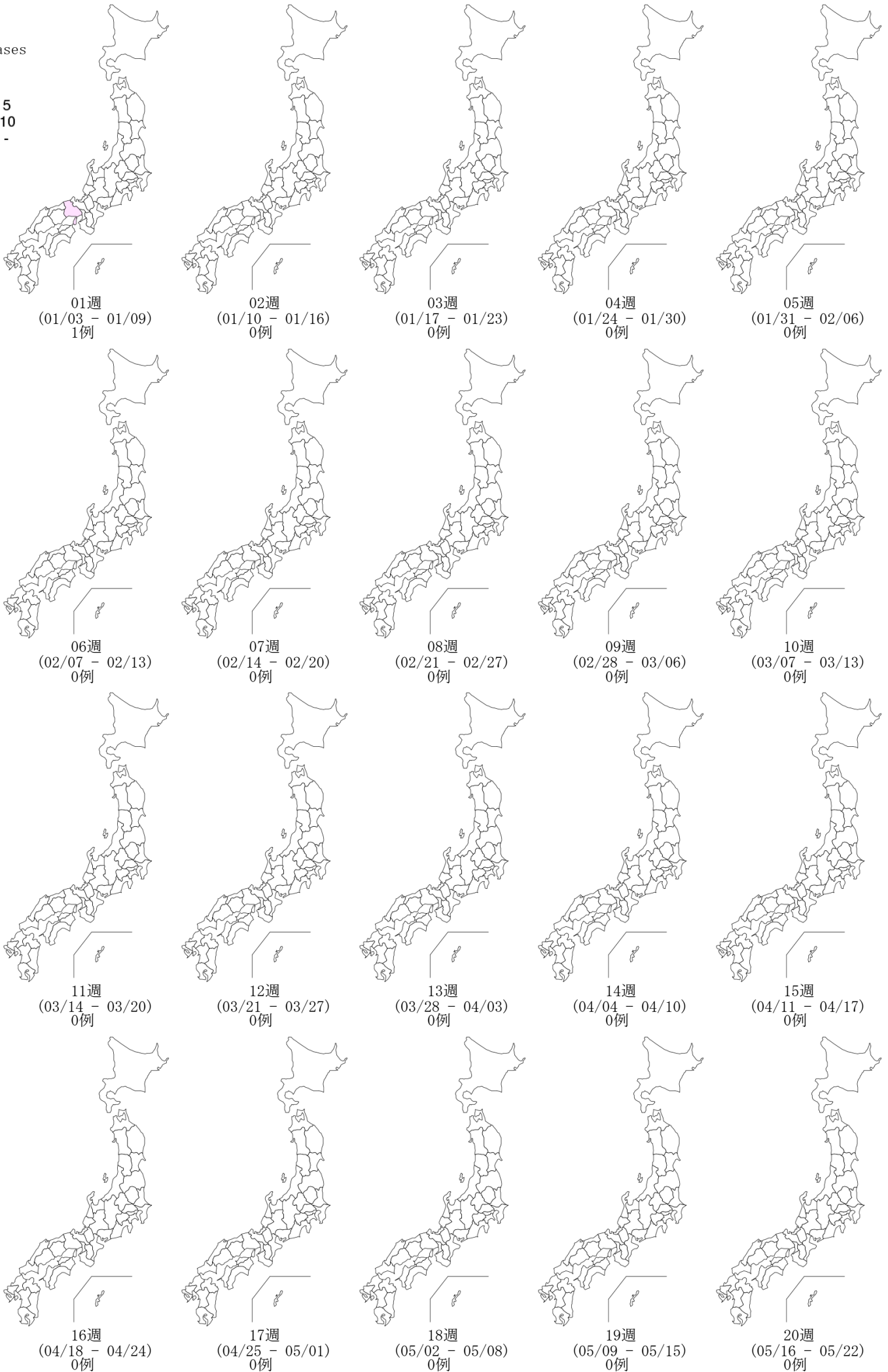
